envio Logistics Limited manages rental payment for vehicle owners whose vehicles are listed on the envio platform. **(mygarage.africa)**

At envio we give express access to drivers, connecting them to vehicle owners who are willing to list out their vehicle to verified drivers with permanent driver's license. To enable us complete the verification process for each driver, we have given him/her the opportunity to nominate a guarantor that will serve as a mentor throughout the tenure of the Rental Agreement.

Our guarantor verification programme allows us connect with prospective mentors of drivers taking cars from our platform.

ELIGIBILITY:

- To be qualified to be a guarantor, we expect you to be at least 5 years older than the driver.
- Have a decent job with a verifiable office address.
- Be ready to provide mentorship to the driver.
- Must reside in same city with the driver.

At envio, we treat guarantors as partners supporting our vision for a safe and accessible public transport and shared mobility system in Nigeria.

NOTE: AS A GUARANTOR, YOU WILL BE CONTACTED FOR VERIFICATION AS IT IS A REQUIREMENT BEFORE OFFER LETTER IS GIVEN TO THE APPLICANT. KINDLY RESPOND WITHIN 24 HOURS. ALSO NOTE THAT THIS GUARANTOR'S VERIFICATION IS DONE UNBEHALF OF THE VEHICLE OWNER.

The person to fill this form must be between 30-50 years old and MUST be any of the following;

1. Senior Civil servant, Grade level 8 and above OR
2. Registered limited Liability Company Owners (a copy of the CAC Certificate of Incorporation should be attached) The Company must have a verifiable Address and Website and must be in Business for 2years.

3. Practicing Professionals (E.g. Architect Accountants, Engineers, **excluding Lawyers &Uniform Personnel**)

4. Equivalent of senior banking Officer in Banks and Deputy Manager of a reputable Company.

N.B any other level of guarantor in conflict with the above stated level is not acceptable.

A Passport Photograph and a copy of guarantor's National ID and current place of employment MUST BE submitted alongside the form.
